POSITION PAPER (PROPOSED) RESOLUTION SUPPORTING LA. SENATE BILL 378 TO AMENDING .R.S. 47:338.203

This position paper is offered by the Jefferson Parish Office of Inspector General ("JPOIG") regarding a proposed resolution supporting an amendment to state law. The Jefferson Parish Council will meet on Wednesday, April 20, 2016. At that time, the Parish Council has before it for consideration a resolution supporting Louisiana Senate Bill 378. The resolution appears as Item 18 on the addendum agenda. *See Attachment A*, Resolution and Agenda. Senate Bill 378 calls for the amendment of Louisiana Revised Statute 47:338.203(D) to provide that the Jefferson Parish Convention and Visitors Bureau ("JCVB") receive the net proceeds of a hotel occupancy tax directly. *See Attachment B*, Senate Bill 378.

Presently, the JCVB is the body designated to receive the tax revenue by Parish ordinance, but the JCVB has no state statutory entitlement to the funds. The JCVB currently receives the funding under terms and conditions set out in a negotiated Cooperative Endeavor Agreement (CEA). In July 2015, the JCVB entered into a CEA with the Parish for a five year term whereby the JCVB commits to provide certain services and deliverables in consideration for receipt of the funding. Other pertinent provisions require the JCVB to (1) provide quarterly narratives of activity; (2) comply with the Louisiana Code of Governmental Ethics; (3) submit to audit by the Parish; and (4) submit to oversight by the Jefferson Parish Office of Inspector General (JPOIG). The proposed amendment to state law would create an entitlement to this funding in favor of the JCVB. The amendment would operate to negate or otherwise compromise enforcement of the commitments made in the executed CEA, as well as, obfuscate oversight. Accountability is the key to maintaining public trust. The JPOIG was created to foster and promote accountability and

transparency. The proposed amendment would also adversely affect the Parish's ability to engage in meaningful oversight. For this reason, the JPOIG presents the following analysis for consideration and recommends a resolution opposing the amendment to state law.

LEGISLATIVE HISTORY

La.R.S. 47:338.203 was first *enacted* by Acts 2004, No. 790 as R.S 33:2740.18.2. It was renumbered as R.S. 47:338.203 in 2011. *See Attachment C*, La.R.S. 47:338.203.

Present Law

La.R.S. 47:338.203 presently provides the following in pertinent part:

A. Notwithstanding any other provision of law, and in addition to any other tax now or hereafter levied and collected, the Jefferson Parish Council, whether acting as the governing authority of Jefferson Parish or as the governing authority of any special district created for the purposes set forth in Subsection D of this Section, is hereby authorized and empowered to levy and collect a tax upon the paid occupancy of hotel rooms located within Jefferson Parish, both unincorporated areas and incorporated municipalities... Fifty percent of the hotel occupancy tax collected within each municipality in Jefferson Parish shall be remitted to the municipality in which it was collected and shall be used for purposes enumerated in Subsection D of this Section to promote and fund programs that enhance visitation and tourism in the municipalities.

- B. The governing authority shall impose the hotel occupancy tax by ordinance adopted by the governing authority which shall have the right to provide in the ordinance or by resolution necessary and appropriate rules and regulations for the imposition, collection, and enforcement of the hotel occupancy tax ...
- D. The net proceeds of the tax after deduction of reasonable collection expenses shall be used to fund ... only a parish-designated body and in the municipalities by a mayor-designated body whose sole purpose is to promote and fund programs that enhance visitation and tourism, such as the programs of the existing Jefferson Convention and Visitors Bureau and the programs of the Kenner Convention and Visitors Bureau. ¹ *See Attachment A*, for full text.

Pursuant to the above enabling legislation, the Parish Council adopted Summary 21355 and Ordinance 22273 in July 2004 calling for a hotel occupancy tax and providing for the collection and use of such tax. *See Attachment B*. By this ordinance, the Jefferson Code of Ordinances was amended to include Sections 35-210 through 35-212. *See Attachment D*, Summary No. 21355 and Ordinance 22273. Section 211 provides, <u>Use of net proceeds tax</u>:

- a) The net proceeds of the tax after deduction of collection expenses shall be used to fund programs and special events relating to tourism in Jefferson Parish.
- (b) In accordance with R.S. 33:2740.18.2(D), the Jefferson Parish Council is **authorized to execute a cooperative endeavor agreement with the Jefferson Convention and Visitors Bureau** relative to the expenditure of the net proceeds of the tax on programs and special events that relate to tourism or in anywise enhance visitation and tourism in Jefferson Parish. (emphasis added) (Ord. No. 22273, § 1, 7-14-04)

Section 35-212 provides for the sheriff to collect the hotel occupancy tax and remit the proceeds to the Parish finance director after deducting a collection fee. Presently, taxes are collected by the sheriff and remitted to the Parish. The revenue is reported by the Parish in its budget as General Fund 10010-5034.

By ordinance, the Parish has designated the JCVB to receive the funds under a CEA. For the past ten years, the Parish has negotiated multiple CEAs with the JCVB under which the JCVB has received and expended revenues generated by this hotel occupancy tax. Specific tourism events are supported by this revenue. The JCVB has also received additional Parish funding through other revenue sources to supplement tourism efforts under amended terms or separate CEAs. Finally, the JCVB operates from office space located in the Joseph S. Yenni government building per terms of the CEAs. Each of the CEAs provide and support oversight by Jefferson Parish.

Proposed Law

The proposed amendment to state law directs that revenue previously received by the JCVB under the terms of negotiated CEAs would be "directed to Jefferson Convention and Visitors Bureau, Inc.,"

ANALYSIS

The resolution before the Council for consideration on Wednesday, April 20, 2016 describes the revenue received by the JCVB as "pass-through" money since the "Jefferson Convention and Visitors Bureau is already authorized to receive the net proceeds from a hotel occupancy tax collected in Jefferson Parish;".... and further that Senate Bill 378 "simply redirects the net proceeds of the above said hotel occupancy tax to the Jefferson Convention and Visitors Bureau instead of being directed to Jefferson Parish as a pass-through to the Jefferson Convention and Visitors Bureau." *See Attached B* Senate Bill 378.

Presently, the JCVB is not statutorily entitled to the proceeds of the hotel occupancy tax. Rather, the JCVB is recognized by ordinance as the body who may receive it under a CEA. The proposed amendment to state law creates a statutory entitlement in favor of the JCVB and effectively eliminates the Parish's ability to ensure accountability and oversight. While the JCVB may be required "to expend revenues to fund programs and special events relating to tourism," the JCVB would have complete discretion to select which "programs and special events" to support, and how to support them. Directing the funds to the JCVB negates the Parish's ability to set expectations and agree upon deliverables as a condition of Parish funding.

The proposed amendment would also likely excuse the JCVB from performance under the current CEA since the CEA is a bi-lateral agreement providing Parish tax dollars for services. Enforcement rests on the Parish's receipt and control of the revenue. Further, and to the extent oversight may be exercised, the quality of oversight would necessarily be hindered as there would be an absence of deliverables against which to assess value or calculate waste.

Lastly, the amendment to state law would eliminate the ability of Jefferson Parish residents to meaningfully engage their Parish Council concerning the use of tax revenue. The amendment to state law would operate to relieve the Council of oversight of expenditure of the taxes which it levies.

SECTION II. That the Jefferson Parish Council hereby supports the streamlining of funding tourism promotion as managed by the Jefferson Convention and Visitors Bureau, so that it may promote tourism in Jefferson Parish with the above said net proceeds derived solely from the hotel industry.

SECTION III. That a copy of this resolution be forwarded to all members of the Jefferson Parish Legislative Delegation as well as the Jefferson Convention and Visitors Bureau and all departments in connection therewith.

SB 378 Original

<u>Present law</u> authorizes the Jefferson Parish Council to levy and collect a hotel occupancy tax within the parish, in both unincorporated areas and incorporated municipalities.

<u>Present law</u> provides that the governing authority has the right to contract with the state of Louisiana for the collection of the tax. Further provides that the tax is in addition to all other taxes presently levied on the occupancy of hotel rooms in the parish.

Proposed law retains present law.

<u>Present law</u> provides that the net proceeds of the tax after deduction of reasonable collection expenses shall be allocated to fund tourism promotion in Jefferson Parish and to fund programs and special events relating to tourism on behalf of the parish by only a parish-designated body with the sole purpose of promoting and enhancing tourism, such as the Jefferson Convention and Visitors Bureau and the programs of the Kenner Convention and Visitors Bureau.

<u>Proposed law</u> retains <u>present law</u> but limits the net proceeds of the tax (after deduction of reasonable collection expenses) to be directed to the Jefferson Convention and Visitors Bureau, Inc. to fund tourism promotion in Jefferson Parish and to fund programs and special events relating to tourism on behalf of the parish with the sole purpose of promoting and enhancing tourism, such as the programs of the Jefferson Convention and Visitors Bureau, Inc.

Effective August 1, 2016.

§ 338.203. Hotel occupancy tax in Jefferson Parish

Effective: August 15, 2011

Currentness

A. Notwithstanding any other provision of law, and in addition to any other tax now or hereafter levied and collected, the Jefferson Parish Council, whether acting as the governing authority of Jefferson Parish or as the governing authority of any special district created for the purposes set forth in Subsection D of this Section, is hereby authorized and empowered to levy and collect a tax upon the paid occupancy of hotel rooms located within Jefferson Parish, both unincorporated areas and incorporated municipalities. The hotel occupancy tax shall be one percent of the rent or fee charged for such occupancy. The word "hotel" as used in this Section shall have the same definition as that contained in R.S. 47:338.201 and R.S. 47:338.202. The hotel occupancy tax shall be paid by the person who exercises or is entitled to occupancy of the hotel room and shall be paid at the time the rent or fee for occupancy is paid. "Person" as used herein shall have the same definition as that contained in R.S. 47:301(8). Fifty percent of the hotel occupancy tax collected within each municipality in Jefferson Parish shall be remitted to the municipality in which it was collected and shall be used for purposes enumerated in Subsection D of this Section to promote and fund programs that enhance visitation and tourism in the municipalities.

- B. The governing authority shall impose the hotel occupancy tax by ordinance adopted by the governing authority which shall have the right to provide in the ordinance or by resolution necessary and appropriate rules and regulations for the imposition, collection, and enforcement of the hotel occupancy tax, including but not limited to a provision that the initial collection of the tax shall begin on the first of a month following the adoption of the ordinance levying the tax. Should the council take action as authorized in this Section to collect the hotel occupancy tax, the collection shall begin no earlier than August 1, 2004. The ordinance levying and imposing the hotel occupancy tax shall be approved by a favorable vote of a majority of the members of the governing authority present and voting. The term "ordinance" means an ordinance, act, or other appropriate legislative enactment of the governing authority.
- C. The governing authority shall have the right to contract with the state of Louisiana for the collection of the hotel occupancy tax. The tax shall be in addition to all other taxes presently being levied upon the occupancy of hotel rooms in the parish.
- D. The net proceeds of the tax after deduction of reasonable collection expenses shall be used to fund tourism promotion in Jefferson Parish and in the municipalities of Jefferson Parish to fund programs and special events relating to tourism, in Jefferson Parish by only a parish-designated body and in the municipalities by a mayor-designated body whose sole purpose is to promote and fund programs that enhance visitation and tourism, such as the programs of the existing Jefferson Convention and Visitors Bureau and the programs of the Kenner Convention and Visitors Bureau.

<"Section 4. The redesignation of a statute as provided by Sections 3 and 4 of this Act shall not affect the validity of the statute, and references to a statute as redesignated shall be valid; however, the redesignation of a statute as provided by Sections 3 and 4 of this Act shall not invalidate a reference to the former citation of the redesignated statute. >

<"Section 7. The Louisiana State Law Institute is hereby authorized to designate new chapters, parts, and subparts of Title 13 of the Louisiana Revised Statutes of 1950 and to designate new parts and subparts of Chapter 2-D of Subtitle II of Title 47 of the Louisiana Revised Statutes of 1950, for those statutes redesignated from Title 33 of the Louisiana Revised Statutes of 1950.>

<"Section 8. The redesignation of statutes as provided in Sections 3 and 4 of this Act shall be completed by January 1, 2012.">

On joint motion of all Councilmembers present, the following ordinance was offered as amended:

SUMMARY NO. 21355 ORDINANCE NO. 22273

An ordinance imposing the hotel occupancy tax in Jefferson Parish as authorized by R.S. 33:2740.18.2, amending Chapter 35 of the Code of Ordinances relative to imposing said tax and providing for the net proceeds of said tax, and providing for related matters. (Parishwide)

WHEREAS, R.S. 33:2740.18.2, enacted by Act No. 790 of the 2004 Regular Session of the Louisiana Legislature, authorizes and empowers Jefferson Parish to impose a one percent hotel occupancy tax upon the paid occupancy of hotel rooms located with in the Parish; and

WHEREAS, the proceeds of this tax are to be used solely and exclusively to fund programs and special events relating to tourism in Jefferson Parish by designated tourism organizations; and

WHEREAS, under R.S. 33:2740.18.2, fifty percent of the tax collected from hotels located in municipalities shall be distributed to the municipalities to be used in accordance with the provisions of said R.S. 33:2740.18.2; now therefore,

THE JEFFERSON PARISH COUNCIL HEREBY ORDAINS:

SECTION I. That Article VII, entitled "Hotel Occupancy Tax) of Chapter 35 of the Code of Ordinances be amended by adding Division 3, Sections 35-210 through 212, to read as follows:

DIVISION 3 TAX AUTHORIZED BY R.S. 33:2740.18.2 Sec. 35-210. Imposed.

The one (1) percent hotel occupancy tax as authorized by R.S. 33:2740.18.2 is hereby imposed on the paid occupancy of the hotel rooms located within Jefferson Parish in addition to all other taxes being levied upon the occupancy of hotel rooms in the parish.

Sec. 35-211. Use of net proceeds of tax.

- a) The net proceeds of the tax after deduction of collection expenses shall be used to fund programs and special events relating to tourism in Jefferson Parish.
- b) In accordance with R.S. 33:2740.18.2(D), the Jefferson Parish Council is authorized to execute a cooperative endeavor agreement with the Jefferson Convention and Visitors Bureau relative to the expenditure of the net proceeds of the tax on programs and special events that relate to tourism or in anywise enhance visitation and tourism in Jefferson Parish.

Sec. 35-212. Collection.

- a) The sheriff of the parish is hereby authorized to collect the hotel occupancy tax imposed by section 35-210 and he shall remit the proceeds thereof to the director of the department of finance after deducting a collection fee of not more than eleven (11) percent of such proceeds.
- b) The director of the department of finance shall distribute to the governing authorities of each municipality located within the parish fifty (50) percent collected from hotels located in each such municipality upon showing by the municipality that it has designated a body in accordance with R.S. 33:2740.18.2(D) to promote and fund programs that enhance visitation and tourism in Jefferson Parish.

SECTION 2. That in accordance with R.S. 33:2740.18.2(B), the provisions of this ordinance shall take effect on August 1, 2004.

The foregoing ordinance having been submitted to a vote, the vote thereon was as follows:

The ordinance was declared to be adopted on this the 14th day of July, 2004, and shall become effective as follows; if signed forthwith by the Parish President, ten (10) days after adoption, thereafter upon signature by the Parish President, or, if not signed by the Parish President, upon expiration of the time for ordinances to be considered finally adopted without the signature of the Parish President, as provided in Section 2.07 of the Charter. If vetoed by the Parish President and subsequently approved by the Council, this ordinance shall become effective on the day of such approval.
