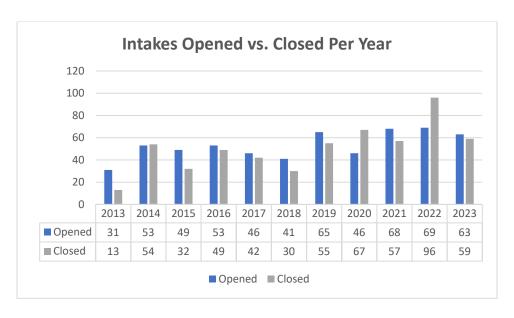
F. Professional Development

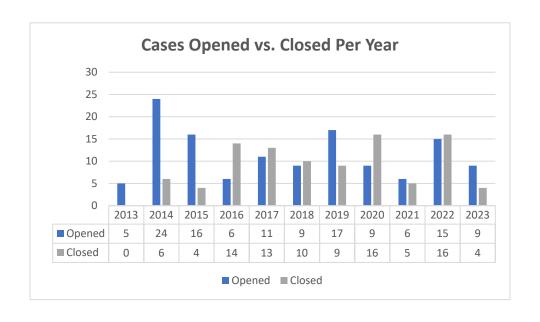
